To Whom it may concern:

Forest County is seeking proposals to replace three overhead doors in the Courthouse Building located at 200 East Madison Street in Crandon, WI.

The work that is to be included includes the following:

1. Demolition and disposal of the three existing overhead doors, operators and weatherstripping.
2. Preparation of each opening to receive the new doors and operators.
3. Furnish and install three commercial doors along with three commercial grade operators.
4. The approximate sizes of the doors are 10 ft x 8 ft. The actual size must be field verified.
5. The doors are to be insulated to a minimum R-Value of 16.
6. The minimum skin thickness of the door is to be 20 ga. Exterior and 27 ga. Interior.
7. Doors to be balanced by a torsion spring counterbalance system constructed of oil tempered torsion springs.
8. Hinges are to be 14 ga. And rollers are to be ball bearing steel.
9. Provide two 24" x 8" windows in each door.
10. Provide three remote controllers that are capable of operating each of the three doors.
11. Provide low temperature vinyl astragal door bottom seal and heavy-duty weather stripping on door sides and door top.
12. Provide all required low voltage and line voltage wiring as required for a complete installation.
13. Do not add for sales tax and the Owner is tax exempt.
14. Provide final cleaning and disposal of all demolition materials.
15. All work must be completed by December 1, 2022

The Owner will review all proposals and select the proposal that best meets the needs of the County. All proposals must be delivered to the Clerk's office Room 201 by 10:00 a.m. on July 6, 2022. Proposals will be publicly read, directly following the opening.

The work may commence at any time following the acceptance of the selected proposal. The date of completion is flexible but must be noted on the submitted proposal.
