

ADVERTISEMENT FOR BIDS

The Beaver Island Airport Commission, Beaver Island, Michigan, will receive bids for the **Beaver Island Airport – Runway 27 Approach Clearing - Phase 2** project, until **11:00 am (local time) Thursday, February 9, 2023**. Bids received after the stated time will not be accepted. Bids will be publicly opened (electronically) and read aloud at the Lansing office of Mead & Hunt, Inc., immediately following the time stated above. Contractors are welcome to attend the electronic bid opening if interested, though attendance is not required.

With their bid, bidders shall submit evidence of qualification meeting the requirements of General Contract Provisions 20-02. Possession by the prime contractor of MDOT prequalification at the time of bidding shall be an acceptable form of evidence. The net classification applicable to the prime contractor for this project is 112 N2. If the prime contractor is not prequalified in the above classifications, prequalified subcontractors must be used. Subcontractors must be prequalified in their respective work area and designated prior to award of the contract to the confirmed low bidder.

There is a zero (0) percent DBE requirement for this project.

Bids will only be accepted online through the www.questcdn.com e-bid process. HARD COPY (PAPER) BIDS WILL NOT BE ACCEPTED.

Bidders will submit a proposal guaranty in the form of a proposal bond, in the amount of not less than five (5) percent of the bid sum. The proposal guaranty shall be made payable to the Beaver Island Airport Commission. If the selected contractor fails to provide the required materials and/or execute the contract within fifteen (15) calendar days after being furnished with the necessary contract and bond forms, the proposal guaranty will be forfeited to the Sponsor in accordance with Section 30-08 of the General Provisions.

The successful bidder will be required to furnish satisfactory one hundred (100) percent performance bond as well as labor and material bond. No bid may be withdrawn after closing time for the receipt of proposals for a period of one hundred twenty (120) calendar days.

The Beaver Island Airport Commission reserves the right to reject any and all bids, and to waive any informalities in bidding or to accept the bids or bid, should it consider same to be in its best interest.

A mandatory pre-bid meeting is scheduled for Tuesday, January 31, 2023 at 10:00 am (local time). The meeting will be held via conference call. Prospective bidders wishing to participate in the call are instructed to contact the Project Manager at ben.hoover@meadhunt.com prior to 9:00 am (local time) on Tuesday, January 31, 2023 to request the conference line number. Prospective bidders are encouraged to visit the project site prior to bidding. The visit should be coordinated with the Project Manager and airport personnel.

Scope of Work

This project consists of removing individual trees and the associated restoration on large wooded parcels. The project shall be complete and ready for final inspection within twelve (12) calendar days from the effective date of Notice-to-Proceed.
